



## Bazaar - Art Show Panel Rules & Regulations

As an added bonus this year we are allowing each Bazaar Table to place 1 (preferably one of a kind) item in the Art Show for bid in the Silent & Live Auction. Please review all Art Show guide lines (included). You may address any questions to [ArtShow@animefest.org](mailto:ArtShow@animefest.org).

### HOURS:

The Art Show will be open to AnimeFest members:

- Friday 8:00 am – 11:00 am -->**Sign-In & Placement**
- Friday 12:00 noon – 7:00 pm
- Saturday 10:00 am – 6:00 pm
- Sunday 10:00 am – 6:00 pm
- Monday 10:00 am – 2:00 pm
- Monday 12:00 noon – 3:00 pm -->**Check-Out & Removal**

Art pieces **must** be in place by 11:30 am on Friday, September 4, 2009.

All art **must** be fully removed no later than 4:0 pm Monday, September 7, 2009.

The Artist is responsible for the removal of art at the end of the convention. Any art not claimed by the artist by 4:00 pm Monday will become the property of AnimeFest, if the Artist does not contact us by October 1, 2009.

### PRICES & FEES:

Bazaar special – one piece free Bazaar Panel in Art Show  
10% Fee – All Art Sold in Art Show/Auction

AnimeFest does not charge a sales tax for art sold in the Art Show or Auction, this is the responsibility of the Artist to pay all appropriate taxes after receiving the proceeds from a sale.

### BAZAAR SPECIAL RULES:

1. Artist must comply with all of the regular Art Show rules
2. The one piece put on the Bazaar – Art Show Panel should not be a piece being sold at your table. This is so that you have a better chance of making more money on the piece in the Art Show.

## **ART GUIDELINES:**

1. Original artwork and limited edition prints are the preferred formats.
2. All artwork must be either properly matted and/or framed; or on board or stretched canvas. Sculpture and any other forms of artwork are also acceptable and encouraged.
3. We would prefer the majority of your art be of an Anime theme but we will accept art with a Science Fiction and Fantasy theme as well. This means we should be able to determine that it fits into one of the above categories through subject matter, character design, or other forms of interpretation to fit the forum we are providing.
4. All Artists, or their representatives, will be responsible for hanging their own art. If you have a representative hang your art, please send a note letting us know that they have the right to do so. If any Artist, or their representative, needs help in hanging the art, please feel free to ask.
5. All pieces are required to be clearly marked, either on the back or underneath, with the Artist's name and the name of the piece. This is to provide us with a way to match piece and artist at the auction, upon pick up, or upon retrieval if the piece doesn't sell. It does not have to be permanent but must be attached well enough to handle moving. When the piece is displayed we will provide identity slips that will need to be placed on or near each piece showing the Artist's name, name of piece, when you or your art arrives.

The Art Show Manager reserves the rights to change or add to these rules as circumstances dictate.

## **COPYRIGHTED MERCHANDISE:**

AnimeFest and its associates will not tolerate the sale or display of illegally manufactured or copied merchandise. There are copyright laws and international trade laws that need to be followed. It is the responsibility of the Artist to deal with copyright laws. The Convention, its staff, and all related personnel, assumes no responsibility for checking copyright permission.

## **ADULT MERCHANDISE:**

AnimeFest is a family convention with minors in attendance. For the Bazaar-Art Show panels we are not accepting adult merchandise. For any adult art you would like to sell your pieces in the Art Show you may rent an adult art panel.

Adult media and merchandise must be sold within accordance to Texas law. The display, or sale, of adult merchandise to anyone under the age of 21 will not be tolerated. Adult merchandise will be displayed in an adult section that will be curtained off from the rest of the Art Show. We **will not** be allowing anything to be hung that we consider obscene, vulgar or in poor taste. We also will not allow any item to be hung or displayed that might infringe on the rights of those to whom the copy right has been granted or that might infringe on the rights of those to whom the copy right has been granted or that might do damage to the value of the characters they own. The Art Show Manager reserves the right to determine if a piece of art will be placed in the adult section.

## **TAXES AND LICENSES:**

Artists shall be responsible for obtaining any licenses, permits, or approvals required under local, state, or federal laws applicable to their activities at AnimeFest. Artists will be responsible for obtaining any tax identification numbers and paying all taxes, license fees or any charges that will come due to any Governmental authority in connection with their activity at AnimeFest. AnimeFest does not charge a

sales tax on art sold in the Art Show or Auction, this is the responsibility of the Artist to pay all appropriate taxes after receiving the proceeds from a sale.

**LIABILITY:**

Exhibitor shall be fully responsible to pay for any and all damages to property owned by Hyatt, its owners or managers that results from any act or omission of Exhibitor. Exhibitor agrees to defend, indemnify and hold harmless, Hyatt, AnimeFest, and their owners, managers, officers or directors, agents, employees, subsidiaries and affiliates, from any damages or charges resulting from Exhibitor's use of the property. Exhibitor's liability shall include all losses, costs, damages, or expenses arising from or out of or by reason of any accident or bodily injury or other occurrences to any person or persons, including the Exhibitor, its agents, employees, and business invites which arise from or out of the Exhibitor's occupancy and use of the exhibition premises, the Hotel or any part thereof.

**SECURITY AND PROVISION:**

AnimeFest will provide guard service during the hours the Art Show is closed. However, the Artist is solely and fully responsible for his or her own exhibit material and should insure its exhibit against loss or damage from any cause whatsoever. All property of an Artist is understood to remain in its care, custody, and control in transit to, from or within the confines of the Art Show.

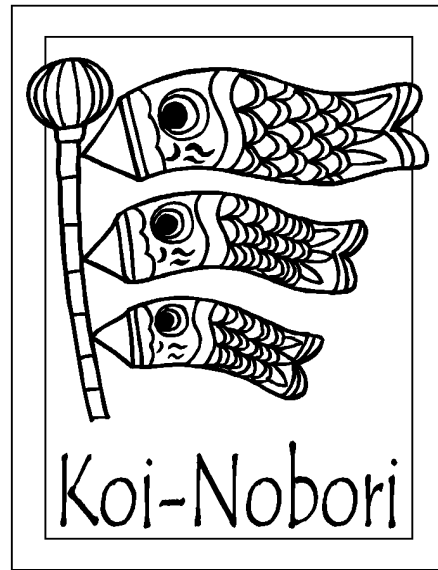
